#### **Meeting Notes**

NOTE: the following notes are intended to supplement the presentation slides used during the meeting.

### **Agenda and Reminders:**

- At the suggestion of OTS at the time of the meeting, an item was added to the meeting under "New Business" to discuss "Tire Classification Training"; all attendees present agreed to the addition of the item, added as Agenda item 8b.
- Technical Committee attendees where reminded that OTS is looking for feedback from
  Participants regarding potential additional costs associated with transporting and processing
  certain types of OTR tires. Participants are encouraged to send comments and supporting

  All materials received will be kept confidential.

#### 1. Diversion Rates: No comments

## 2. Tire Collection Update:

OTS noted that there has been no change in Pre-Program tire program for some time; suggestion
to remove this as a standing update item unless there is a change; agreed to by participants
present and will not be included in next meeting slides unless there is a change

## 3. Tire Delivery & Transportation:

 OTS made adjustments to the South Eastern rates in specific FSAs to reflect limited capacity in processors located in the area. Feedback from committee members indicates that the adjustments may not be enough; OTS is in continuous discussions with the Processor(s) to determine capacity and will either adjust rates or look at the implementation of a redirect rate as applicable (on PLT tires)

## 4. Processing & Manufacturing Update:

 A question was posed regarding where the Processing Incentives fell in comparison to those of other programs in Ontario; based on information available to OTS, the Ontario Processing rates are the second highest compared to other tire programs in Canada

## 5. Claims Update:

 A Processor using the new online claims tool asked if OTS could look into labelling each form entry (i.e. first TCR form would be entry 1 etc.) so that when filtering results, it would be easier to identify where in the hardcopies that form could be located; OTS will look into this with IT. For now, the entire form listing can be exported into excel to determine the overall order of the forms

#### 6. Stockpile Update:

- A Hauler noted that in some areas the Ministry of the Environment officials have begun to request updates regarding "stockpiles"; OTS has been in contact with the MoE and continues to develop their approach to remediation

#### 8. New Business:

- Discussion pertaining to duel role participants led to the general consensus that duel role participants were in existence prior to the program and is not something seen as a result of the program specifically; OTS will continue to monitor incentive levels and adjust based on market efficiencies in a manner consistent with the annual incentive and fee review
- OTS has noticed that some participants are having difficulty classifying used tires (i.e. a PLT is classed and recorded as an MT in error); OTS requested assistance in creating training materials to aid in tire classification (i.e. pictures, difficult tire types etc); positive feedback from meeting attendees and numerous volunteers will be helping OTS create the material in the coming few months
