Meeting Notes

NOTE: the following notes are intended to supplement the Powerpoint presentation slides used during the meeting.

1. Diversion results to date

- a. PLT diversion rate = 80%, MT exceeds 100%, OTRs exceed 130%.
- b. Processing capacity is expected to increase by 4 5M PTEs in 2011.
- c. Estimated % of Deliveries sent out of Province 25% 30% PLT / MT, 60% OTR
- d. "Diversion" refers to tires being diverted from stockpiles / landfills / burning as TDF. No tires have been sent to landfill or Tire Derived Fuel since the program started.

2. Tire Transportation and delivery

- a. Transportation Incentive Rates (2011 Updates)
 - i. New, separate rates for PLT, MT, OTR will be finalized and announced before Dec. 31, 2010
 - ii. Suplus Ad Hoc rates will be changed to a single rate regardless of pickup location and destination, and announced before December 31, 2010.

Note: Concern expressed by some participants that Haulers will travel to closest destination which may penalize more remote out of province processors. Processors and Haulers may work together to "share" TI and PI to encourage Haulers to travel further

- b. Hauler Consultation Meeting scheduled Wednesday, January 12, 2011: to review and discuss new OTR and Surplus rates
- c. 155 Haulers are registered with OTS as of November 2010. Some participants expressed concern about tire supply being spread out over an increasing number of Haulers, however, OTS will continue to register Haulers who meet the minimum requirements.
- d. Feedback from some Haulers is that some haulers / collectors are "stealing" tires from their customers.

 Haulers should contact law enforcement authorities if wrong-doing is suspected. OTS' role is to administer the Used Tire program and can only act if registered participants are not meeting the terms and conditions of their agreements with OTS.

3. Tire Processing & Manufacturing in Ontario

- a. The Ontario First policy forms the basis of programs like the Temporary Tire Storage option for Ontario Processors to store tires for up to 90 days to help manage the seasonal fluctuations in tire supply. This program will be announced December 20 and continues to April 30, 2011 and is available to registered Ontario Processors only.
- b. Guaranteed Supply (GS) will not be continued in 2011 to help ensure adequate tire supply for the growing capacity in Ontario
- c. Processors encouraged to advise OTS of planned shutdowns during the holiday period, or any future interruptions to normal processing e.g. planned maintenance
- d.PTR form: the sequence of weigh scale information and weigh scale ticket number are different than on the Claims spreadsheet. OTS will consider this for the next printing of the PTR form.
- e. Manufacturing Incentives consultation session held Nov. 24 some concern expressed that the session did not invite 2-way communications or feedback on the new MI rate approach for 2011.
- f. 31 Processors are registered including those located outside Ontario. OTS' intent is to list Processors on the website who are actively accepting and processing tires. OTS may deregister processors who have become inactive and are no longer able to accept tires.

4. Program Communications

- a. STC Events current requests will be deferred until spring 2011 given the high tire volume currently and the winter weather affecting access to the STC storage locations.
 - i. a fee may be charged to residents to get the STC tires in adequate (clean) condition to be picked up and processed.
- b. Operational training "refresher" for Participants
 - i. Collectors: December 1 training session held
 - ii. OTS plans to host webinars for all Participant groups during 1Q 2011
 - "Refresher" training focusing on claims
 - iii. Individual participant sessions may be available on request
