Meeting Minutes

Agenda:

 Encouraged participation and noted that comments can be submitted via email following the meeting in the timelines specified as applicable

1) Diversion Rates

- Collection figures for PLT an MT down slightly over last year
- OTR volume is up

2) Tire Collection Update

- No issues reported

3) Tire Transportation & Delivery

- On road tires remain in province
- Redirects/ad hocs consistant.
- STC's higher in August than previous months
- Reminder of proper and accurate Yard counts as these are used in the OTS database.

4) <u>Tire Processing & Manufacturing Update</u>

- Capacity for all tire types have increased over last year on average
- Variations seen with OTR capacity; Out of Province Processor available for OTR tires

5) Claims Updates

- Collector Claims: filed as normal
- Processor Claims: filed as normal
- RPM claims: filed as normal
- Reminder to haulers that a yard count is mandatory for November 2012
- Negative inventory still an issue
- Processors Increase in weight variance is occurring recently (Total Estimated Weights extremely higher than Scale Weights)
- Explanations could not be provided for the first 2 examples of the weight variance (see slides)
- A penalty system is being considered which was challenged as to the rights of OTS to implement such changes

6) Stockpile Updates

- OTS is continuously working with MoE on stockpile sites and removal options
- A RFP is currently being developed and will be issued in the coming weeks/month(s)
- End use of material and cost will still be taken into account.

7) Program Communications

- No refresher training sessions planned (individual sessions still continue where applicable)

Other Communication Updates:

- HST cheques for Haulers have been sent for the claim periods of
- September 2009 to March 2012.
- HST cheques for Haulers for the April to June 2012 claim period, OTS anticipates to send out cheques by the end of November 2012.
- HST cheques for Collectors from September 2009 to June 2012 claim periods are anticipated to be sent out by the end of December 2012.
- Community program launched in August Deadline November 15th, 2012
- Education module continuing
- Design challenge site unveiled September 17th at Evergreen Brick Works.
- Several events available for viewing on the GreenMyTires website and in presentation

8) Tire Education Guide

- A thank you to the individuals who have come forward to offer their expertise in creating a tire education guide.
- The guide will be created to complement the existing tire definitions in the program plan.
- The intent is to show illustrations and other aids to help provide further clarity for tire classifications.

9) FSA Zones

- Currently over 510+ FSA zones in Ontario
- Simplifying the model and consolidating the FSA zones into miniOzones with weighted average TI's calculated for each zone
- Current TI rates are being reviewed and will be share with the stakeholders towards the end of the year.

10) Update of Tire and Stewardship Fees

- Fees will be changing in 2013
- No change to how Collectors, Haulers, Processors and RPM's file claims
- No change for PLT and MT categories; OTR's will be broken up into weight categories (slide presentation)
- Industrial Tires if tire is pneumatic, it will fall into the OTR weight categories; separate weight categories for Solid & Resilient tires (slide presentation)
- Industrial over 251kg will fall into the pneumatic categories for PTE
