### 1) Diversion Update

- Diversion rates shown based on data available to OTS in late
  September 2012 (OTS notes that some data not yet finalized despite revised submission timelines) for Q2 2012
- Data presented is in DRAFT at this time
- Collection figures for PLT and MT down slightly over last year, OTR volume is up

Tire Category	<b>Diversion Rate</b>
PLT	97%
MT	98%
OTR	130%



## 2) Tire Collection Update

- Tires being collected from locations by Haulers as applicable
- No issues to report



### 3) Tire Transportation & Delivery

a) Ad Hocs & Redirects: requests for OTRs redirects/ad hocs remain high, very few On Road requests (only for cut MTs; OTS currently looking into ways to deter cutting of tires from rims)

Ad Hoc and Redirects:

Ad Hocs authorized in April = 11

Ad Hocs authorized in May = 6

Ad Hocs authorized in June = 6

Redirects authorized in April = 19

Redirects authorized in May = 5

Redirects authorized in June =4

## 3) Tire Transportation & Delivery

b) STC Review/Updates:

Number of STCs approved in May: 4

Number of STCs approved in June: 0

Number of STCs approved in July: 2

Number of STCs approved in August: 11

Note: STC requests have slowly increased throughout the summer months compared to the previous quarter.



## 4) Tire Processing & Manufacturing Update

- Capacity for all tires types increased over last year on average
- Variations still seen with OTR capacity
- Manufacturers: actively participating in promotional activities with OTS
- Additional out of province processor available to handle OTR tires



### 5) Claims Update


- Collector Claims:
- Collector claims filing in accordance with typical trends
- Hauler Claims:
- Yard Count required for all haulers with their November 2012 submission.
- Issues with "negative inventory" continue; typically a result of data entry errors, tire misclassifications (misclassifications can lead to delays in claim processing as it is sometimes difficult to identify the error) or missing paperwork
- Haulers filing in accordance with typical trends



### 5) Claims Update

#### **Processor Claims:**

- Processors claims continue to be filed as normal
- An increase in weight variance has been occurring recently between weight scales and the estimated weights of the loads.
- A new established penalty system is being considered for weight variances
- Examples:



#### **RPM Claims:**

Continue to file as usual



### 6) Stockpile Update

- OTS is working with stockpile sites to come up with removal options
- Participants with questions regarding stockpiles can direct them to info@ontariots.ca
- Contract awards will consider end use of material (i.e. TDP type and supply to an RPM) as well as cost
- Currently the team is assessing the stockpile locations with the assistance of MoE enforcement officers to determine the status/condition of the stockpile



## 7) Program Communications

#### **Refresher Training Sessions:**

- Currently no refresher training sessions are planned
- Individual training sessions continue as applicable (typically with new participants)

#### Other Communication Updates:

- HST cheques for Haulers have been sent for the claim periods of September 2009 to March 2012.
- HST cheques for Haulers for the April to June 2012 claim period, OTS anticipates to send out cheques by the end of November 2012.
- HST cheques for Collectors from September 2009 to June 2012 claim periods are anticipated to be sent out by the end of December 2012.



### **Program Communications – con't**

- OTS 2012 Community Grant Program launched in August. The deadline for applications, which can be found on GreenMyTires.ca, is November 15, 2012.
- Continuing Education Module promoting Recycled Tire Products to Designers and Developers debuted September 26 to members of Parks & Rec Ontario. More presentation opportunities are in development. The course has received OAA and GBCI accreditation.
- Advertising campaign directed at Ontario Architects and Builders promoting tire-derived Products will launch in Q4.
- OTS 2011-12 Design Challenge Site was unveiled September 17 at Evergreen Brick Works. ### 8) Tire Education Guide

- Thank you to those individuals who have come forward thus far and expressed interest in aiding in the preparation of a Tire Education Guide and for sending in pictures etc.
- The Tire Education Guide will be developed in conjunction with Stewards and participants and will complement the existing tire definitions in the program plan
- Illustrations, pictures and other aids will be included in the guide to help provide clarity in tire classification to those in the field



### 9) FSA Zones

- As per usual, TI rates are continuously reviewed throughout the year
- Currently there are over 510+ FSA Zones in Ontario, each with their own TI rates
- Looking into simplifying this system and consolidating FSA zones into mini-zones with weighted average TI's calculated for each zone.
- Current TI rates are being reviewed and once completed, they will be shared with the stakeholders regarding the new zones.



### 10) Update of Tires and Stewardship Fees

- OTS will be issuing revised guidance to Stewards regarding categories and criteria to be used when reporting on supply of new tires into Ontario.
- This guidance will only be in effect going forward, and will not be applied retroactively.
- Tire Definitions methodology moving away from classification based on tire use or rim diameter and to classification based on tire weight. This results in tires being reported in program categories that more closely align with operational costs incurred by the stewardship activities associated with that tire.
